Application for Distance Learning 2020-2021 School Year (4th Quarter)

Thank you for choosing GFA's Distance Learning option. We are excited to offer your child an alternative to the traditional classroom setting in response to the COVID-19 pandemic. We are committed to making sure that your child continues to experience the care and commitment of our teachers and staff, and the routine of robust daily learning, through our distance learning program. In this option, students will receive instruction through pre-recorded lessons, video conferencing, class assignments, readings, and class activities through Canvas. Our goal is to provide your child a full learning experience. The following highlights the guidelines for our distance learning option.

- This agreement is for 4th Quarter only and can be renewed each quarter by application.
- Students participating in distance learning will be able to check out a school device for use at home if needed. Parents will be required to complete a Chromebook computer checkout application.
- Students will receive instruction through pre-recorded lessons and video conferencing primarily through Canvas.
- Attendance will be required and recorded by the teacher as per state law for those learning at home. Students should login each day for assignments and instructions from the teacher. If your child is unable to login due to illness, parents must notify the school to excuse the absence as if the student was attending school. Poor attendance may result in the withdrawal from our distance learning program as determined by the teacher and administration.
- Students will participate in the learning of all new grade level material and are expected to complete all required assignments on time as if the student was attending school.
- Distance Learning students can expect equivalent grading as in-school students.
- Students are required by the Utah State Board of Education to participate in all DIBELS reading assessments for all grades and RISE assessments for grades 3-6. Students must be physically present for testing. Teachers will schedule these assessments and follow all COVID-19 enhanced safety precautions during testing.
- In the event of unforeseen circumstances, and a distance learning student would like to return to the classroom, the school needs prior notice of at least 3 days to make the appropriate accommodations.

Here are some guidelines for Parents to support distance learning:

- Establish routines and expectations. A regular daily learning routine will help your child to learn more effectively at home.
- Define the physical space for your child's study.
- Monitor communications from your child's teacher.
- Take an active role in helping your child process and own their learning.
- Ensure that your child is completing all required assignments and submitting these to their teacher in a timely manner.
- Remain mindful of your child's stress or worry.
